This tendency represents a serious risk of a fragmentation of the Digital Single Market. The Commission asked the Body of European Regulators for Electronic Communications (BEREC) to undertake a fact-finding exercise on issues crucial to ensuring an open and neutral internet, including barriers to changing operators, blocking or throttling of internet traffic, transparency and quality of service. The results of this investigation identified several restrictions that consumers are subject to and unaware of. The Commission is thus preparing a Recommendation that will provide guidance on transparency, traffic management, switching an the respect of the users' privacy by ISPs when they apply certain traffic management tools (such as Deep Packet Inspection (DPI)). This aims at ensuring that Member States take similar approaches towards net neutrality and will thus contribute to the achievement of a Single Market for electronic communications.
