1. Introduction

EUSurvey, as an application developed by the Commission of the European Union, is committed to user privacy. The policy on protection of individuals with regard to the processing of personal data by the Community institutions is based on Regulation (EC) N° 45/2001 of the European Parliament and of the Council of 18 December 2000.

The legal basis for this processing is Article 5(a) of Regulation (EC) 45/2001 and its provisions establishing the European Data Protection Supervisor and setting out his duties and powers.

2. Description and purpose of the processing

The EDPS launches an online survey of the views of EDPS staff to measure staff satisfaction. The survey is being carried out by the EDPS. This is done through the EU Survey, application developed by the Commission of the European Union. Individual responses will be processed by the HRBA Unit in accordance with Regulation 45/2001 and the specific privacy notice relating to the online survey.

3. Controller - Processor

The European Data Protection Supervisor is the controller.

Data processed is under the responsibility of the Head of Unit of DIGIT.A.3, Directorate-General for Informatics (DIGIT) of the European Commission. The DIGIT's Data Protection Coordinator ensures that the provisions of the above-mentioned regulation are applied within DIGIT.

4. Personal data and how we use them

This statement only covers the corporate service dimension of EUSurvey. EUSurvey will process the personal data only for the purposes for which they were transmitted.

Identity

The survey owners (the EDPS) sign up to ECAS (the EC's Authentication Service).

EUSurvey stores the ECAS login as well as e-mail addresses of the survey owners such as retrieved from ECAS and the European Commission's Central User Database which is stored at the Data Centre of the European Commission. The Data Centre of the European Commission is bound to comply with Regulation (EC) N° 45/2001.

Other personal data

In addition to the personal information processed by the EUSurvey service itself, there are only two mandatory personal data (grade (AD, AST or other) and gender) we request from you within questionnaires.

The email address will only be used for sending the link to participate in the said survey. It is stored by EUSurvey and is not intended for sharing with the survey owners.

Participation to the survey is totally voluntary and for all questions, there is always a possibility to reply "no answer" or "no opinion".

How we use your data

The EDPS will use the replies to create and analyse aggregated statistics and will never use the personal data for any other purposes. The EDPS will only have access to the content of the answers in an anonymous form and will not be informed of the identity of the respondents.
