4/ Purpose or purposes of the processing

The purpose of processing is to collect the external spontaneous and sollicited applications for jobs and calls for interest of the European Commission and the other participating institutions in a searchable electronic format. Candidates fill their CVs and applications themselves via the Internet.

This system replaces the manual or semi-manual processing of over 30.000 spontaneous applications for the Commission alone with an harmonised system. The application furthermore supports the selection and recruitment process until the signature of an employment contract. Finally, the personal identification and CV data of the recruited persons are transferred to the personnel management system of the recruiting institution. An interface to the Commission's system Sysper2 is foreseen. Until then, this data transfer is done in a manual transaction and may be limited to the personal identification. The e-CV data transfer to the Sysper2 e-CV will be triggered by the data subjects themselves who can import the data from EU CV online

Candidates can access the system online via the internet without interruption. They can access their personal data and e-CV information, modify and delete it.

Applicants can modify their application until the elapse of the application deadline, then they have access to the application file and can request factual corrections by e-mail to the EU CV online helpdesk. Candidates can limit the access to their personal data and their e-CV to themselves, so that no other recipient can access them. In this case, only the automatic and anonymous searches are operational on the CV. If such a candidate applies to a specific vacancy or call, then their personal data and CV data become accessible to the recipients of the application.

Recruiting services can operate a search based on the professional specifications of a job, receive a statistical analysis on the CVs that are found, and can send a message to all persons that correspond to the search criteria.

Users from recruiting services and their Human resources departments can browse and search e-CVs. The search facilities for recruiting services are limited to professional information that does not directly identify the applicant.

HR staff can also search for individual candidates.

Applications are fully visible and searchable for the recruiting service and their HR departments. From an application, candidates can be "marked" by a service for upcoming positions where they may well fit.

If inactive, the e-CVs will actually not be searchable, not be exploited in anonymous searches, and they are only accessible for a reactivation by the candidates themselves.
