Clearance of Accounts Audit Trail System (CATS-database) and additional information.

4/ Purpose or purposes of the processing

CATS is a support system intended to assist the auditors of Directorate J in the context of the Clearance of Accounts procedure. CATS data is used by the auditors in the context of the EAGF/EAFRD (EAGGF-Guarantee) expenditure related audits. Data may include reference to the final beneficiary and to specific personal data - name, address, etc.

Also the European Court of Auditors (ECA) and OLAF have full access to the CATS database for their inquiries.

CATS data can also be used for monitoring developments and providing forecasts in the agricultural domain. When making use of the accounting data for the above mentioned purposes the Commission, Directorate J, aggregates and renders data anonymous. Totals (such as total amounts or total quantities, for a region and/or a budget item and/or a size class of beneficiaries) are always reported, but not if the number of final beneficiaries if less than 10 (note AGRI-015977 of 21/06/2006 on CATS confidentiality and retention rules).

The auditors use the Audit Command Language (ACL) software after downloading data from the CATS database for preparing and performing audits on the EAGF/EAFRD (until financial year 2006: EAGGF Guarantee) expenditure.

Within this context, auditors can store personal data on their desktop PCs or on their laptops; furthermore auditors also can file the printed information in their audit binders.

Any other additional personal data relating to EAGF/EAFRD beneficiaries, collected and processed outside the CATS database, can also be used by the auditors in the context of the EAGF/EAFRD expenditure related audits.

The accounting data in CATS is stored for a limited period. After a period of 10 years (7 years financing period + 3 years clearance of the accounts), personal data fields will be dropped from the CATS database.

Auditors can store personal data on their desktop PCs, their laptops and, can also file printed information (derived from CATS and/or collected and further processed in the context of desk audits and on-the-spot checks) in their audit binders.

Therefore, the data controller requests all Directorate J staff to destroy all computer files containing personal data and older than 10 years including extracts or copies of personal data kept by the auditors on local computers, in local folders, on CD-ROM, floppy disk or in audit binders, etc.

To get access to the clearance of accounts database CATS, Directorate J's auditors have to confirm the provisions of the retention policy of personal data relating to CATS and any other additional personal data, collected and further processed in the context of desk audits and on-the-spot checks.
