**SUPERVISORY OPINION 07/2026**  
**ON THE DRAFT INTERNAL RULES CONCERNING**  
**THE PROVISION OF INFORMATION TO DATA**  
**SUBJECTS AND THE RESTRICTION OF CERTAIN**  
**DATA SUBJECTS' RIGHTS IN RELATION TO THE**  
**PROCESSING OF PERSONAL DATA BY THE**  
**EUROPEAN COMMISSION FOR THE PURPOSE OF**  
**THE INVESTIGATION, ENFORCEMENT AND**  
**MONITORING UNDER THE FOREIGN SUBSIDIES**  
**REGULATION**  
**(Case 2026-0397)**

## 1. INTRODUCTION

1. This Supervisory Opinion relates to the draft decision of the European Commission ('the Commission') laying down internal rules concerning the provision of information to data subjects and the restriction of certain data-subjects' rights in relation to the processing of personal data by the Commission for the purpose of investigation, enforcement and monitoring under Regulation (EU) 2022/2560 ('the Foreign Subsidies Regulation').<sup>1</sup>

2. The European Data Protection Supervisor ('EDPS') issues this Supervisory Opinion in accordance with Articles 41(2), 57(1)(g) and 58(3)(b) of Regulation (EU) 2018/1725<sup>2</sup> ('the Regulation').

## 2. FACTS

3. On 9 April 2026, the Commission submitted a consultation request regarding its draft decision 'laying down internal rules concerning the provision of information to data subjects and the restriction of certain data-subjects' rights in relation to the processing of personal data by the European Commission for the purpose of investigation, enforcement and monitoring under Regulation (EU) 2022/2560 of the European Parliament and of the Council' ('the draft decision').
4. The EDPS has analysed the draft decision and makes the following comments.

## 3. LEGAL ANALYSIS

5. The EDPS welcomes the fact that the Commission timely consulted the EDPS on its draft decision, and notes that the preamble of the draft decision states that the EDPS was consulted.
6. The EDPS further welcomes that the Commission has partially made use of the model internal rules provided as Annex II to the EDPS Guidance on Article 25 of the Regulation and internal rules restricting data subject rights.<sup>3</sup>

7. Concerning the right to information, the EDPS notes that the Commission will publish a data protection notice on its website, including information on the potential restrictions of data subjects' rights in the context of investigation, enforcement and monitoring under the Foreign Subsidiaries Regulation. The EDPS observes that the information shall cover which rights may be restricted, the grounds on which restrictions may be applied and their potential duration, as well as the right of data subjects to lodge a complaint with the EDPS. In addition, the EDPS notes that the Commission shall individually inform, by appropriate means, legal representatives and staff members of undertakings under investigation, and informants, about the processing of their personal data in that context.<sup>4</sup>
8. The EDPS also notes that the Commission will carry out and document a case-by-case assessment of the necessity and proportionality of any restrictions before their application.<sup>5</sup>
9. The EDPS welcomes that the Commission will document the restrictions for accountability purposes and make the files available to the EDPS upon request.<sup>6</sup>
10. Furthermore, the EDPS welcomes that the Commission shall review the application of restrictions applied every six months and that the review shall include an assessment of the necessity and proportionality of the restriction.<sup>7</sup>
