We wanted to come back to you with a question that came out in the copy editing phase of the summary **Rules of procedure of the European Data Protection Supervisor**, that you have validated, in the paragraph mentioned below regarding **bimonthly visits**.

**Monitoring data protection**

- The EDPS must guarantee effective protection of rights and freedoms of individuals through the **monitoring and enforcement** of Regulation (EU) 2018/1725 and any other EU law that sets out tasks and powers for the EDPS.
- In carrying out its investigative, corrective, authorisation and advisory powers, the EDPS may carry out **compliance visits, surveys, bimonthly visits** and **informal consultations** or encourage **amicable settlements of complaints**.

Article 13 of Decision of the European Data Protection Supervisor (Monitoring and ensuring the application of the Regulation) in the English version mentions "bi-monthly visits", which can mean either twice a month or every 2 months.

But looking at other versions of the act, we found that the FR version (as well as the ES one) mentions "visites bimensuelles" (twice a month), while the IT (and the PT) mentions "visite bimestrale" (every 2 months)... We could not find any other reference in official sites that clarifies this.

Could you please help us to clarify this issue?
